## Basil Bacon – Morning Times Writer

Basil spoke to the Catholic Charities move. Mrs. Woods informed him they gave a 30-day notice that they were moving out. He also spoke to concerns regarding open meeting law requirements for agendas and meeting minutes.

Departments Reports – Note- complete reports are on file in the Town Clerk's office.

<u>Highway</u> – Monthly report on file. Will reiterated highlights from his report. His main concern is the need for a new mower. The quote came in for just over \$37,000.

Full Depth Replacement on Green Road – Town of Nichols has responsibility for a portion of this road. The cost for FDR is \$11,000. This section will be done by Town of Owego and Vestal Asphalt will pave. This should come out of "regular" highway money – not CHIPS money.

Some of our equipment has lived out its life and should be termed excess and sent to auction: 1992 Trac excavator and a 1997 backhoe should be sent to auction. It was determined that these two pieces of equipment will be termed excess and sent to auction.

<u>Building & Grounds</u> - Report on file. Nelson Tree Company took care of trees in the cemetery.

*Fire alarms – there are issue with phone lines at the highway garage. Cellular coverage was discussed and will be looked into.* 

<u>Sewer/Water</u> –Bob's report was in the packet- Sewer code was reviewed. Bob will be in contact with Brenda with the updates. Fiber has not yet been installed at the well house due to some "pre-installation" work that needed to be done. The NYSEG electric meter as replaced. Per Bob it's been a 'quiet" month. He is in need of a new printer – it was agreed that he will take one from the clerk's office.

<u>Code Enforcement</u> – Best Buy (rack system) phase 2 has started. It should be done this year. There were other permits issued for town businesses and homeowners. It was also noted a denied ZBA permit was reworked and permit issued.

<u>Historian</u> – Kem presented information regarding book preservation. She noted that Kofile, who has been used before, is downsizing. HF Group is a new formed

company from ex-Kofile employees. The group very comparable to Kofile and she is recommending for various reasons to go with the new company. The have the 1865-1940 Books of Mortgages preserved is \$1467.

WHEREAS, the Town of Nichols scheduled a public hearing for May 28, 2024 at 6:00 p.m. for Local Law No. 2 of 2024 entitled "A LOCAL LAW AMENDING THE TOWN OF NICHOLS ZONING CODE TO REDUCE THE MEMBERSHIP OF THE ZONING BOARD OF APPEALS FROM 5 TO 3 MEMBERS"; and

**WHEREAS,** notice of said public hearing was duly advertised in the official newspaper of the Town and posted on the Town Clerk's signboard; and

**WHEREAS,** the Tioga County Planning Department reviewed the Local Law pursuant to GML § 239-m and has issued a report thereon; and

**WHEREAS**, said public hearing was duly held on the 28th day of May, 2024 at 6:00 p.m. at the Nichols Town Building, 139 Roki Blvd, Nichols, NY and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and

**WHEREAS**, pursuant to the State Environmental Quality Review Act, it has been determined by the Town Board that adoption of the proposed Local Law constitutes a Type II Action as defined under 6 NYCRR 617.5(26) and (33); and

**WHEREAS,** the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said Local Law.

**NOW, THEREFORE BE IT RESOLVED** that the Town Board hereby adopts said local law as Local Law No. 2 of 2024 entitled "A LOCAL LAW AMENDING THE TOWN OF NICHOLS ZONING CODE TO REDUCE THE MEMBERSHIP OF THE ZONING BOARD OF APPEALS FROM 5 TO 3 MEMBERS"; and be it further

Not a lot going on for some time. <u>LEPC</u> - No report – Emergency Preparedness event will be Oct 19, 2024 9AM at Nichols Fire Department – more information to come. <u>Council of Governments</u> – Brenda attended. These are zoom meetings – but they are sending out the recordings.

#### Old Business:

Town Hall Locks – This continues to be worked on. Cameras for Town Building – Tioga County is coming to evaluate Town Hall and other buildings to see what areas need more cameras.

Old Town Barn – Tioga County came to evaluate property at the new town barn to see if we could build on the property. Awaiting to hear back to see if it's "buildable".

Depot Road Project - Waiting for FEMA reimbursement.

FEMA Properties— These are still being worked on. The most the town would be responsible for is "up to" \$9500 per house.

Five-year Plan - waiting on quotes for various projects. We should include the cemetery and to also complete the fiber project for the entire town.
