RESOLUTION 07-2021

TO PURCHASE

PERMANENT EASEMENT AND RIGHT-OF-WAY

At a meeting of the Town Board of the Town of Nichols held at Town Hall, 54 East River Road, Nichols, New York on the 14th day of December, 2021, the following resolution was offered and seconded:

WHEREAS, the Town of Nichols desires to enter into a Permanent Easement and Right-of-Way Agreement with Jessica Woods regarding a certain parcel of land identified as tax parcel number 149.00-1-18.21, and located in the Town of Nichols ("the Premises"); and

WHEREAS, the Town of Nichols requires an easement and right-of-way to the Premises in to order to perform improvements to the Hunt Creek drainage system for the public benefit; and

WHEREAS, upon the purchase of the easement and right-of-way by the Town of Nichols, the sum total of \$1.00 would be payable to Jessica Woods in consideration thereof, in addition to other good and valuable in-kind consideration, as set forth in the Permanent Easement and Right-of-Way Agreement; and

WHEREAS, the Permanent Easement and Right-of-Way Agreement referenced above is attached as **Appendix A**; and

WHEREAS, the Town has a public interest in the property transaction for the protection of the adjacent public highway and the Hunt Creek drainage system; and

WHEREAS, the Town Board has exercised due diligence in inspecting the property and determining the value thereof; and

WHEREAS, that pursuant to Part 617 of the implementing regulations of the State Environmental Quality Review Act, it has been determined by the Town Board that the purchase of a permanent easement and right-of-way constitutes an Unlisted Action. The Town Board has considered the possible environmental impacts of the action and has determined that it will not have a significant adverse impact on the environment and the Town Board adopts a negative declaration with respect thereto.

NOW THEREFORE BE IT RESOLVED, that the Supervisor of the Town of Nichols be and hereby is authorized to execute any and all necessary legal documents to enter into the aforementioned Permanent Easement and Right-of-Way Agreement; and

BE IT FURTHER RESOLVED, that, pursuant to Town Law §64(2), this resolution is subject to permissive referendum.
