### **RESOLUTION TO PURCHASE TEMPORARY EASEMENT AND RIGHT-OF-WAY**

At a meeting of the Town Board of the Town of Nichols held at Town Hall, 54 East River Road, Nichols, New York on the 12th day of April, 2022, the following resolution was offered and seconded:

WHEREAS, the Town of Nichols desires to enter into a Temporary Easement and Right-of-Way Agreement with Crown Cork & Seal USA, Inc. and the Tioga County Industrial Development Agency regarding a certain parcel of land identified as 149.00-1-46 and located in the Town of Nichols ("the Premises"); and

**WHEREAS**, the Town of Nichols requires an easement and right-of-way to the Premises in to order to perform improvements to the Hunt Creek drainage system for the public benefit; and

WHEREAS, upon the purchase of the easement and right-of-way by the Town of Nichols, the sum total of \$1.00 would be payable to Crown Cork & Seal USA, Inc. and the Tioga County Industrial Development Agency in consideration thereof, in addition to other good and valuable in-kind consideration, as set forth in the Temporary Easement and Right-of-Way Agreement; and

**WHEREAS**, the Town has a public interest in the property transaction for the protection of the adjacent public highway and the Hunt Creek drainage system; and

WHEREAS, the Town Board has exercised due diligence in inspecting the property and determining the value thereof; and

WHEREAS, that pursuant to Part 617 of the implementing regulations of the State Environmental Quality Review Act, it has been determined by the Town Board that the purchase of a temporary easement and right-of-way constitutes an Unlisted Action. The Town Board has considered the possible environmental impacts of the action and has determined that it will not have a significant adverse impact on the environment and the Town Board adopts a negative declaration with respect thereto.

**NOW THEREFORE BE IT RESOLVED**, that the Supervisor of the Town of Nichols be and hereby is authorized to execute any and all necessary legal documents to enter into the aforementioned Temporary Easement and Right-of-Way Agreement; and

**BE IT FURTHER RESOLVED**, that, pursuant to Town Law §64(2), this resolution is subject to permissive referendum.

### ADDITIONAL NEW BUSINESS FROM BOARD MEMBERS -

R. Cole mentioned she was looking through the Supervisor's report and saw the figure for the Auditor that is working on the Town's books was going over the budgeted amount, she wanted to know if the Board needed to make a resolution to transfer money to that line item. K. Engelbert said that the Town has the funds and that when the check is cut it will be designated to the proper department.

K. Engelbert had a conversation with OSC Auditors regarding the cell phone allowance and it can be considered as compensation and not a wage to be taxed. K. Engebert said if the majority of those getting the allowance would like to go back to the way it was prior, to let him know. R. Thetga, B. Nugent and W. Heveland all agreed to keep it the way it is right now. K. Engelbert also told them it can also be changed at the beginning of next year if they wanted.

### UPDATE FROM TOWN DEPARTMENTS/PERSONNEL -

Highway Department - W. Heveland told the board that the Loader that was ordered shall be arriving in a week or two. Tri County Tree Service, who has the County contract for tree removal, was contacted and said that he could work for the Town for \$800.00 per day, plus fuel cost and use of the our Highway crew to remove some trees and limbs. Discussion followed about cost, how long it may take and how many trees needed to be taken care of.

Motion to hire Tri County Tree Service at \$800.00 per day plus fuel cost, contingent that the Tioga County contract possesses the requisite "piggybacking" language that says Tri County Tree Service can be used by other municipalities and that a copy of said contract is made available for the Board to review, made by K. Engelbert 2nd by R. Cole.

*W.* Heveland to get a copy of the Tri County Tree Service Tioga County Contract and give it to the Town Clerk so she can scan and email it to the Board Members to review.

W. Heveland wanted to know if he could get a dollar figure for paving the Town's roads not including CHIPS money. K. Engelbert Town should be good for \$1,000,000.00 this year. Discussion followed regarding the seven projects W. Heveland would like to do. These total up to approximately \$783,631.00. The Board told W. Heveland if the funds aren't coming in from Tioga Downs then some roads may have to wait until next year. K. Engelbert said that the Town should already have the money on hand and that the Town can continue to do more if Tioga Downs keeps doing the business that they are doing. W. Heveland also stated that CHIPS funding might be increasing this year and the Board felt that W. Heveland should start working on the road projects since the funds are there.

Buildings and Grounds - R. Thetga, Jr has started his season and it was confirmed by the Board that, until further notice, he will still be mowing FEMA properties. R. Thetga, Jr gave an estimate on pricing for 2 A/C units at \$7,975.00. This figure did not include installation or labor and was only for the Boardroom at NES and a smaller room. The company he talked to doesn't do roof protrusions and they would require a roofing company to do that. K. Engelbert asked why R. Thetga, Jr was looking into A/C units and B. Middleton stated that it was in case the rest of the Town Hall would move up to the school and the Board wanted to find out the cost to do it. Discussion about how many units are on the building and which rooms they go to followed. K. Engelbert read aloud a letter from Catholic Charities detailing the work they do for our residents. Supervisor Engelbert said that Catholic Charities is requesting to rent the front office of NES if Tioga Opportunities leaves and he would like to see those rooms go to them and he feels it's convenient for the residents to go to Town Hall, Bank, Dollar General and get a meal all in the same area. He also felt it is convenient for the Town Clerk and the Bookkeeper to be able to go across the street to the bank. K. Engelbert would like the Board to consider leasing the front offices to Catholic Charities, especially since Catholic Charities does so much for our community and our residents. Discussion followed if the rooms were available and if Tioga Opportunities was up to date with the rent. K. Hall to attempt to contact someone at Tioga Opportunities and find out what they are planning to do. The Board talked about the Carriage Barn and that it still would require maintenance regardless if the rest of Town Hall moves up to the school or not.

*R.* Thetga, Jr stated that he is still working on getting his CDL and getting as much drive time as he can. His permit is good until the end of July and he plans to take his test before then.

Water Sewer - R. Nugent said that he needed to replace the pressure valves in the well house and replace the electrode probes at the Wastewater Plant. He presented the Board with estimates from: Ross - \$3,916.00 with \$104.00 in parts from Grianger for valves and

Xylem, YSI Inc - \$4,500.00 for probes

R. Nugent said that he would make the repairs himself.
Motion to approve purchase of parts and make repairs made by B. Fay-Pelotte 2nd by R. Cole.

*R.* Nugent told the Board he is using one basin at this time but next winter he wants to use 2 basins.

Historian - K. Hart-Baker created a guest list for people coming to visit the Museum. The books that were approved have been sent out to Kofile. She requested to go to the 2022 NYS Historians Conference being held in Kingston, NY in September. No decision has been made at this time.

## OLD BUSINESS -

Hazard Mitigation Grant - E. Woods told the Board that Hunt Engineering is doing the process of grant writing and she is still waiting to hear from Tim Steed the engineer to find out the cost. Discussion followed about letting the residents know that this is available to them if they would like to participate.

Shared Services/Upstate Towns Association - B. Middleton said there was no Shared Services meeting planned, however there is an Upstate meeting coming up.

COG/Compressive Plan - B. Fay-Pelotte said that COG is looking at purchasing bulk phones and copiers to see if there is any value for purchasing in bulk for all Towns. Senator Ashkar talked about the Pave Our Potholes initiative and that could bring the Town some extra funding. B. Fay-Pelotte mentioned that Pennsylvania is ahead of New York State regarding their MRTA (Marijuana Regulation and Taxation Act) and they have brought in \$500,00.00 in their first year and that they also had spent more money on law enforcement as well.

REAP/Hazard Mitigation - R. Cole is going to a meeting on May 5th regarding Hazard Mitigation that relates to emergency services. The last meeting for REAP also discussed County emergency response time to calls, talked about the challenges that everyone has with getting volunteers and a grant for a copier. Discussion followed regarding call volume, paid staff, and having shared/joint EMS service.

## ADDITIONAL OLD BUSINESS FROM BOARD MEMBERS -

## ADDITIONAL PUBLIC COMMENTS -

Mark Hanford asked for clarification on the 4,000 sq ft definition on the Solar Farm and he asked for consideration from the Board regarding the hazards to people and animals from Solar Farms and for the Town to have some sort of risk mitigation plan to choose a site not near residences.

K. Coughlin said anything less than 4,000 sq ft is considered a Minor Solar and over 4,000 sq ft is considered a Major Solar Farm. This was so a homeowner could have solar for their home if they wanted without going through a Major site plan.

Howard Stoltzfus asked if the temporary easement was going through Crown Cork and Seal grass yard on their property and requested that the drainage on Hunts Creek be addressed when the road is redone. The response, yes, traffic will be rerouted on that easement on Crown Cork and Seal property and the engineers are looking at drainage improvements on both sides of the road.

### ACCEPT REPORTS AND PAY BILLS -
