1. The transfer of \$1,200,000.00 from the A Fund (town general fund) to the DA Fund (town highway fund); and

2. The transfer of \$200,000.00 from the B Fund (town outside village fund) to the DB Fund (town outside village highway fund).

TOWN OF NICHOLS RESOLUTION #13-2022 AUTHORIZING THE APPLICATION FOR A JUSTICE COURT ASSISTANCE PROGRAM GRANT

At a meeting of the Town Board of the Town of Nichols, held at the Town Offices on the 28th day of September, 2022, the following resolution was offered and seconded:

WHEREAS, the Nichols Town Justice has requested to apply for a Justice Court Assistance Program grant from the Office of Court Administration for up to \$30,000.00; and

WHEREAS, the grant funds would be used to make certain improvements to the Town Court system, including a security wand, metal detector, witness stand, audio visual equipment and other equipment upgrades; and

WHEREAS, the Town Board finds it in the best interests of the Town to apply for said grant; and

NOW THEREFORE BE IT RESOLVED that the Town of Board of the Town of Nichols hereby authorizes the Town Justice to apply for a Justice Court Assistance Program Grant for the above-referenced purposes; and

RESOLVED, that this resolution will take effect immediately.
