Cady Library - Deb Stubecki, Library Trustee, sent an email to E. Woods. She had concerns regarding lighting and security for the Library when the Town Hall moves to the school. B. Middleton to go to the Library Board of Trustees Meeting on November 15, 2022 to address those concerns.

ADDITIONAL NEW BUSINESS -

UPDATE FROM TOWN PERSONNEL -

Highway - W. Heveland stated that the monies budgeted for the Highway Department isn't sufficient to cover fuel, pipes, gravel, shop supplies, guardrails etc. B. Woods told him that his budget is \$100,000.00 and he will receive \$258,000.00 in CHIPS, this is all the Highway Department will have for road repair in 2023. According to the state accountants the Town can only use money raised in property taxes, sales tax, and CHIPS for that account line. The casino money is not allowed to be used for road repair accounts and property taxes will have to be raised in the future. W. Heveland wants to have Tri County Tree Service, which was discussed at the April 12, 2022 meeting, do tree maintenance along the roads at \$800.00 per day. He asked the Board how much they can budget at this time.

Motion to hire Tri County for 10 days of tree removal at \$8,000.00 made by B. Middleton 2nd by R. Cole. Roll Vote;

Hunts Creek Project - E. Woods and B. Fay-Pelotte to meet with Hunt Engineering on 11/9/2022 at NES at 8:45-9:00 am to discuss hiring them as the Engineering firm. B. Fay-Pelotte mentioned that the Town will also reach out to Delta and McFarland so they also receive a RFP.

NES - The electrical, phone and computer lines have been installed. Sheet rock will be hung next week.

Library Porch Repair - E. Woods talked with the Town Attorney and he does not think the Town can hold building permits from Nichols ReConstruction. The Board discussed that it would cost more money to take Nichols ReConstruction to court and have the porch fixed, than to re-bid it and get the porch fixed.

OTHER OLD BUSINESS -

R. Cole told the board that *W.* Heveland was going to submit the road repair bill for the damage done by Truman Kittle to the Town's insurance company. Then an invoice would be sent to *T.* Kittle to pay the cost of the deductible the Town will have to pay. She said that *W.* Heveland didn't know how to start that process. *K.* Hall said that she would tell him who to contact the following morning.

R. Cole also told the Board that the NJFD will be putting an effort into revitalizing their EMS squad. B. Middleton was asked to be the Town Board liaison. Discussion followed about the Town's shared services agreements with the NJFD and that there was a countywide decision to not allow the fire departments to remove trees that are on Town roads at night. The Board will review any agreements the Town has with NJFD.
